PAY RISES AT MYER

As a result of negotiations between Myer and the SDA, a wage increase totalling \$18.20 per week will apply, from the first full pay period on or after 1 July 2017, to all full-time adult Level 1 team members covered by the <u>Myer Stores Agreement 2010</u> (pro rata increases apply for part-time and casuals). Myer has advised that they will absorb the wage increase for employees on 'saved higher' rates of pay.

Wage increases apply to all team member classifications for full-time, part-time, casual and junior team members.
