# CONDITIONS OF ENTRY TO THE SDA TERIARY EDUCATION ASSISTANCE PROGRAM

1. The Shop, Distributive & Allied Employees' Association, NSW Branch ("SDA") offers ten (10) \$1,200.00 Tertiary Education Assistance Program ("TEAP") payments in 2018 for University students. Successful Applicants will receive this payment for the year 2018 only.
2. The SDA also offers six (6) \$600.00 TEAP payments in 2018 for TAFE or other tertiary college students. Successful Applicants will receive this payment for the year 2018 only.
3. All Applicants agree to be bound by the "Conditions of Entry". Further, all applications must comply with the "Conditions of Entry". Failure to agree or comply with the "Conditions of Entry" will invalidate that application.
4. Applications for the SDA Tertiary Education Assistance Program are limited to financial members of the SDA.
5. To remain eligible for the TEAP payments, successful Applicants must remain a financial member of the SDA for the year of grant.
6. The SDA will determine the successful Applicants from all applications received by the SDA on or before 2 February 2018. No applications received after this time will be considered.
7. Successful Applicants will be notified by post in February 2018.
8. Applications for the SDA TEAP are limited to those financial members of the SDA who are enrolled, or intend to enrol, in a University, TAFE or other tertiary college, either as a full-time or part-time undergraduate student for the 2018 academic year.  
  
The phrase "full-time and part-time undergraduate student" includes those students who are enrolled or intend to enrol in distance education courses.  
  
The phrase "full-time and part-time undergraduate student" does not include students enrolled or enrolling in postgraduate courses.  
  
Proof of enrolment must be provided to the SDA upon request.
9. All decisions regarding the award of TEAP payments by the SDA are wholly at the SDA's discretion and are final. No further correspondence will be entered into.
10. Each application received will be assessed on its merits, including the following criteria:
  - (a) Academic record of the Applicant;
  - (b) Level of the Applicant's community involvement; and
  - (c) Financial needs of the Applicant.
11. Successful Applicants who are University students shall receive two (2) instalments of \$600.00, one (1) for each half-year University semester, during the calendar year 2018.
12. Successful Applicants who are TAFE or other tertiary college students shall receive two (2) instalments of \$300.00, one (1) for each half-year TAFE or other tertiary college semester, during the calendar year 2018.
13. It is a condition of receiving TEAP payments that successful Applicants who are University students are required to submit to the Secretary, not later than 30 June 2018 and 31 December 2018 respectively, receipts to the value of \$600.00, as proof of appropriate use of the TEAP payment.
14. It is a condition of receiving TEAP payments that successful Applicants who are TAFE or other tertiary college students are required to submit to the Secretary, not later than 30 June 2018 and 31 December 2018 respectively, receipts to the value of \$300.00, as proof of appropriate use of the TEAP payment.
15. It is a condition of receiving TEAP payments that successful Applicants do not use their TEAP payment or payments for the purposes of paying tuition fees or Higher Education Contribution Scheme (HECS) payments. TEAP payments can, however, be used towards administrative costs such as enrolment fees.
16. The phrase "appropriate use of the TEAP payment" in points 13 and 14 above is defined to mean direct costs incurred by the Applicant in and for the course of his or her study. The Secretary retains the exclusive discretion of determining what items may constitute "appropriate use of the TEAP payment". No payment will be made for item(s) deemed not an "appropriate use of the TEAP payment".
17. A failure to provide the SDA with receipts by the above mentioned dates shall, at the discretion of the Secretary, result in forfeiture of any further moneys otherwise payable under the TEAP.
18. The SDA may require, from time to time, a progress report from the successful Applicant.
19. In the event a successful Applicant withdraws from his or her studies after:
  - (i) receipt of the first instalment, the moneys received shall be repaid in full to the SDA within twenty-eight (28) days and no further payment shall be made;
  - (ii) receipt of the second instalment, the amount received for the second instalment only shall be repaid in full to the SDA within twenty-eight (28) days.
20. All Applicants must complete an "Application Form" in the approved form attached to the "Conditions of Entry".
21. All "Application Forms" must be signed personally by the Applicant, who by his or her signature agrees to be bound by the "Conditions of Entry".
